Engage with Development of the 10th Dietary Guidelines

The U.S. Department of Health and Human Services (HHS) and the U.S. Department of Agriculture (USDA) are excited to announce the members of the <u>2025 Dietary Guidelines Advisory Committee</u>! The Committee will review the current body of nutrition science and make recommendations to help guide HHS and USDA as they develop the 10th edition of the Dietary Guidelines for Americans.

The Committee consists of 20 nationally recognized scientists. Committee members will examine the relationship between diet and health across all life stages. They will apply a health equity lens throughout their evidence review to ensure their recommendations to HHS and USDA consider factors like socioeconomic status, race, ethnicity, and culture to the greatest extent possible.

Starting on January 19, 2023, a public comment period will open and remain open throughout the duration of the Committee's work. HHS and USDA encourage the public to participate in the process by attending the Committee meetings and <u>submitting public comments through the Federal Register</u>. Also, anyone can <u>sign up</u> for email alerts to stay updated throughout the process. The Committee will hold its first meeting on February 9-10, 2023. Growing Minds – Farm to School Funding – Due 2/15

The Appalachian Sustainable Agriculture Project (ASAP), Growing Minds program wants to help fund your farm to school project in Western North Carolina! This mini-grant program connects K-12 schools throughout the 18 westernmost counties of North Carolina with local agriculture and gives children positive experiences with healthy local foods through the four components of farm to school: farm field trips, local food cooking and taste tests, school gardens, and local food served in school cafeterias. Farm to school activity mini-grants will be provided up to \$1000. Mini-grant applications are due every month on the 15th through April 15, 2023, and will be awarded by the 30th of each month! Apply for Professional Development Scholarships – Due 1/31 and 3/31

The deadlines for the Reginald Ross Inclusion Scholarship and Dr. Lynn Harvey First Timer Scholarship are January 31, 2023. The Reginald Ross Inclusion Scholarship Award was established to honor the outstanding service of Reggie Ross as the President of the School Nutrition Association (SNA) for the 2020-2021 year. In his honor, the School Nutrition Association of North Carolina (SNA-NC) will provide an Annual National Conference (ANC) scholarship to SNA-NC members who has never attended ANC. The scholarship will provide \$1500 to help with registration, hotel, and travel costs. In honor of Dr. Lynn Harvey having proudly represented North Carolina as the 2017-18 SNA President, three First Timer Scholarships will be awarded annually to SNA-NC members who have never attended the state conference. The scholarship will provide complimentary registration and \$500 towards conference expenses to each recipient. Learn more and apply.

The deadline for School Nutrition Foundation Professional Development Scholarships has been extended to March 31, 2023! School Nutrition Association (SNA) members can achieve their educational dreams with a scholarship from the School Nutrition Foundation. These scholarships are intended to provide funding for tuition and books for the following school year. Three (3) scholarships are available for 2023: Superhero Scholarship from Bart Christian (multiple scholarships available each year), Schwan's Food Service Scholarship (multiple scholarships of up to \$2,500 each), and the Nancy Curry Scholarship (one scholarship of \$500 is awarded each year, funded by Handgards, Inc., and friends of Nancy). Promote School Meals and Farm to School with the N.C. Jr. Chef Competition!

Did you know the #NCJrChef Competition is a great way to promote school meals and farm to school? Through participation in the competition, students create school lunch entrée recipes that meet National School Lunch Program regulations, feature at least two North Carolina grown ingredients and one USDA Foods item, and appeal to students. The competition is a wonderful learning opportunity!



For the 2023 N.C. Jr. Chef Competition (NCJCC), teams of 2-4 high school students (grades 9-12) currently enrolled in a North Carolina public school that participates in the National School Lunch Program are encouraged to work with an Adult Team Supervisor (School Nutrition Administrator or Public School Educator – Ag, Family and Consumer Sciences, Math, Science, etc. Teacher) to create a school lunch entrée recipe. Student members of the top three teams will win scholarships to attend Sullivan University.

This year, teams will work together at their schools to develop and test their recipe, complete competition requirements, and submit required materials. Based on applications and recipes submitted, up to eight finalist teams will be selected to compete in the virtual cook-off. Finalist teams will participate virtually in interviews with a panel of evaluators and a recognition ceremony.

- February 3 Teams must submit the online submission form with application, recipe, recipe photo, cost and nutrient analysis, and permission forms.
- February 20 Finalist teams will be notified.
- March 10 Finalist teams must submit the online submission form including final applications with recipe, recipe photo, cost and nutrient analysis, video of the team preparing and plating their recipe, and a work plan for completing the dish within the 90-minute time limit.
- March 28 or 29 Finalist teams will participate in live interviews with a panel of evaluators.
- March 30 Finalist teams will participate in virtual ceremony. All finalist teams will be recognized, and the competition results will be announced.
- May 11-12 The NCJCC first-place team will advance to the Southeast Jr. Chef Competition at Sullivan University in Kentucky.
