#### Learn about Healthy Meals Incentives Awards – 9/21, 3 pm ET

As part of a cooperative agreement to implement the U.S. Department of Agriculture (USDA), Healthy Meals Incentives Initiative, Action for Healthy Kids (AFHK) has launched the Healthy Meals Incentives Recognition Awards to celebrate School Food Authorities (SFAs) that have made significant improvements to the nutritional quality of their school meals. The awards will spotlight innovative practices, student and community engagement activities, and strategies that SFAs have used to provide meals that are consistent with the 2020-25 Dietary Guidelines for Americans. SFAs can apply for one or more of the following award categories:

- Breakfast Trailblazer
- Small and/or Rural SFA Breakfast Trailblazer
- Lunch Trailblazer
- Small and/or Rural SFA Lunch Trailblazer
- Innovative School Lunch Makeover
- Innovation in the Cultural Diversity of School Meals
- Innovation in the Preparation of School Meals
- Innovation in Nutrition Education

SFAs are eligible to apply for the Recognition Awards if they participate in the National School Lunch Program and/or School Breakfast Program. Applications will be reviewed on a rolling basis over a two-year application period ending June 30, 2025.

## Register for a Charter School Boot Camp

The N.C. Department of Public Instruction (NCDPI), Office of School Nutrition is thrilled to provide two upcoming workshops, the "Boot Camp for School Nutrition Personnel in Charter Schools: How to Effectively Manage the Risks and Navigate the Regulatory Waters of the Federal School Nutrition Programs".

Sign-in starts at 8:30 am. The workshop runs from 8:45 am-4:00 pm. Register by Tuesday, October 10. The same content will be provided at each workshop, so please register for and plan to attend only one workshop. Participants are responsible for all travel expenses including breakfast, lunch, beverages, snacks, lodging, and mileage.

This intensive course was designed specifically for Charter School personnel who administer and/or operate School Nutrition Programs. The day-long workshop will provide valuable information about the complex rules and regulations of the Federally-assisted School Nutrition Programs and your responsibilities for implementing the rules as a program administrator or manager. Some questions answered during the workshop include:

- How do you know what to prioritize when managing School Nutrition Programs?
- How do you maintain program compliance with the regulations to avoid costly findings and required corrective actions?
- How do you minimize the risk of non-compliance which may result in the reclaim of funds and adversely impact the status of your charter?
- What strategies help Charter Schools comply with program regulations while simultaneously providing nutritious, appealing meals to students?

Participants will review the basic requirements for operating a successful and compliant School Nutrition Program. The topics chosen for this workshop are cited as the most challenging for Charter Schools to correctly implement. The following topics are often cited as "findings requiring major corrective actions" in eighty percent of Charter Schools participating in the School Nutrition Programs:

- Meal pattern
- Offer versus Serve
- Accuracy and accountability in meal counting, claiming, and consolidation
- Cash management procedures
- Standardized recipes
- Production records as the legal basis to substantiate reimbursable meals
- Purchases using school nutrition funds
- Succession plans to train new Charter School personnel in the event of staff turn over

Upon completion, the workshop will provide 6 hours of credit for professional development as required by the U.S. Department of Agriculture in the learning code 3000 Administration. Charter Schools' personnel are required to participate in a minimum number of professional development workshops annually to achieve and maintain good standing in the School Nutrition Program.

This is a terrific opportunity to strengthen your knowledge and skills in the management of the School Nutrition Programs while minimizing the risks which may, unintentionally, undermine the integrity of your program. # Learn about the Farm to School Technical Assistance Cooperative Agreement – Deadline 10/10

The Patrick Leahy Farm to School Program is proud to announce the release of the FY 2024 Farm to School Technical Assistance Cooperative Agreement Request for Applications (RFA). This RFA supports the Farm to

School Program's ability to provide technical assistance to farm to school stakeholders; expand farm to school activity nationwide; and contribute to the accomplishment of three USDA priorities: Food System Transformation, Improving Child Health Through Nutritious School Meals, and Indigenous Food Sovereignty. USDA will fund up to four total applicants using three tracks: Supporting Community Engagement, Supporting Tribal Engagement, and Supporting Producer Engagement. Eligible applicants include 501(c)3 non-profit organizations and Indian Tribal Organizations (ITOs). USDA will award approximately \$3 million in Farm to School Cooperative Agreement funds. The Saratoga Cornell Cooperative Extension (CCE) USDA Food Hub Feasibility Study Webinar Series will be of interest to all who are in any way connected to our food supply – farmers, farmers markets, supermarkets, food banks, etc. The Food Hub Feasibility Study webinar series explores the findings of a study conducted by Saratoga CCE, which was funded by the USDA's 2021 Local Food Promotion Program grant. They offer recommendations to best service the local food system that considers farm to institution, distribution, infrastructure, food access, the emergency food system, and climate change.
